May 9-12 - ACE US Conference

AmCham Turkey Executive Director Aslı ÖZELLİ participated to the AmChams in Europe (ACE) US Conference in Washington D.C. The annual meeting took place for the first time after 2 years in person. With a strong participation of 30+ Chambers, this year's 5-days program, initially included meetings in Washington with the U.S. Chamber of Commerce, U.S. Department of State, U.S. Department of Commerce, Office of the U.S. Trade Representative, and US Congress.

The discussions were centered on

- the transatlantic relations and their solid strengthening by the war in Ukraine,
- the implications but also the possible developments in the transatlantic economies and business from the
 ongoing disruptions in the energy supply,
- the increasing cost of raw materials and inflation,
- the key issues in the negotiations between the USA and the EU
- and especially those to be discussed at the upcoming new round of TTC next week.
